**President Report:** The President presented the following report to members listing the achievements of the club over the past year.

#### The approval authorisation from CASA to increase our ceiling height from 400ft to 1500ft. The

#### Installation of the low flying warning horn.

**Front Sign**; A special mention to Paul Somerville and his crew for designing and building the new frame for the front sign. I think the club will blow away before the sign does. In Paul's typical way this structure weighed a ton and needed about 10 helpers and the forks to put it in position. Well done Paul.

**Scale Events**; Ivan Chiselett and Andrew Smallridge have spent many weeks and months organising the Scale Day and Monty Tyrrell Rally. It takes a lot of effort to make such days as this work seamlessly. It appears that these events are gaining momentum in attracting a large number of sponsors eager to be involved.
